What is the LEA's proposed timeline for providing services and assistance to students and staff?

Beginning March 14, 2020, the district began its planning for communication with staff/parents and establishing practices to support eLearning. All expenditures will be expended by September 30, 2022.

How will the LEA use ESSER funds to promote remote learning?

The funds will be used to provide Chromebooks, CIPA-compliant content filtering services, and hotspots for students and staff who report need of these resources.

In consulting with the private schools, they are opting to use funds for materials and supplies for cleaning, technology resources, and professional development. We are talking to each of our private schools individually. Most are using funds this summer and early fall as school starts back. All expenditures will be expended by September 30, 2022.

 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
- (8) that the local educational agency has adopted effectiva procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

Contracted tutors/substitutes to support eLearning Barners that arise will be addressed on an individual basis by referral to an administrator and/or student assistance counselor in order to generate a plan that will remove said barriers.
